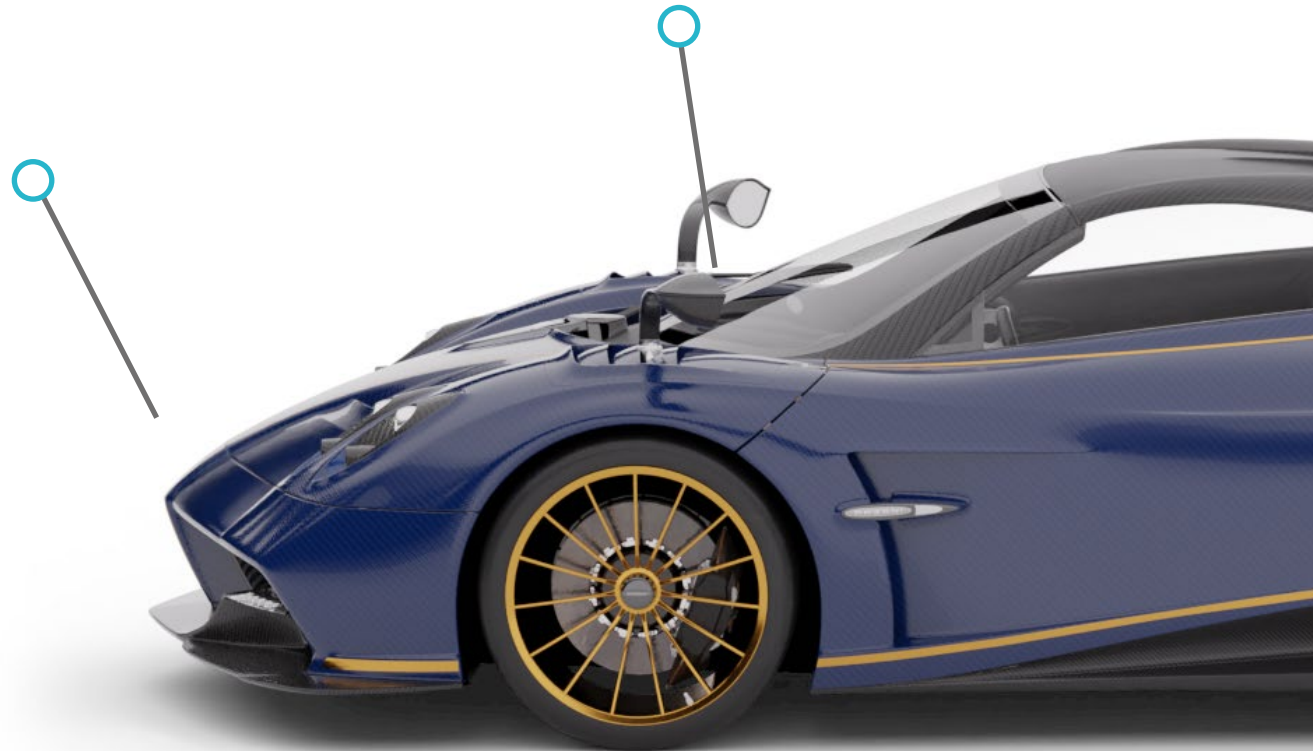
You're not just renting or leasing a vehicle; instead, you become a co-owner of your desired sports car at a fraction of the purchase price. Vehicles in the category above CHF 200,000 often incur daily rental costs exceeding CHF 1,000. A week, inclusive of mileage, can easily amount to CHF 6,000 - 10,000, while a month can surpass CHF 15,000.

2. Independent of banks - no leasing

Leasing - also known as renting - is a euphemism for renting.... Similarly, you're not merely the owner; instead, you make a monthly installment for the vehicle's usage. However, as a co-owner, you make a one-time payment for the vehicle's usage until it's sold.

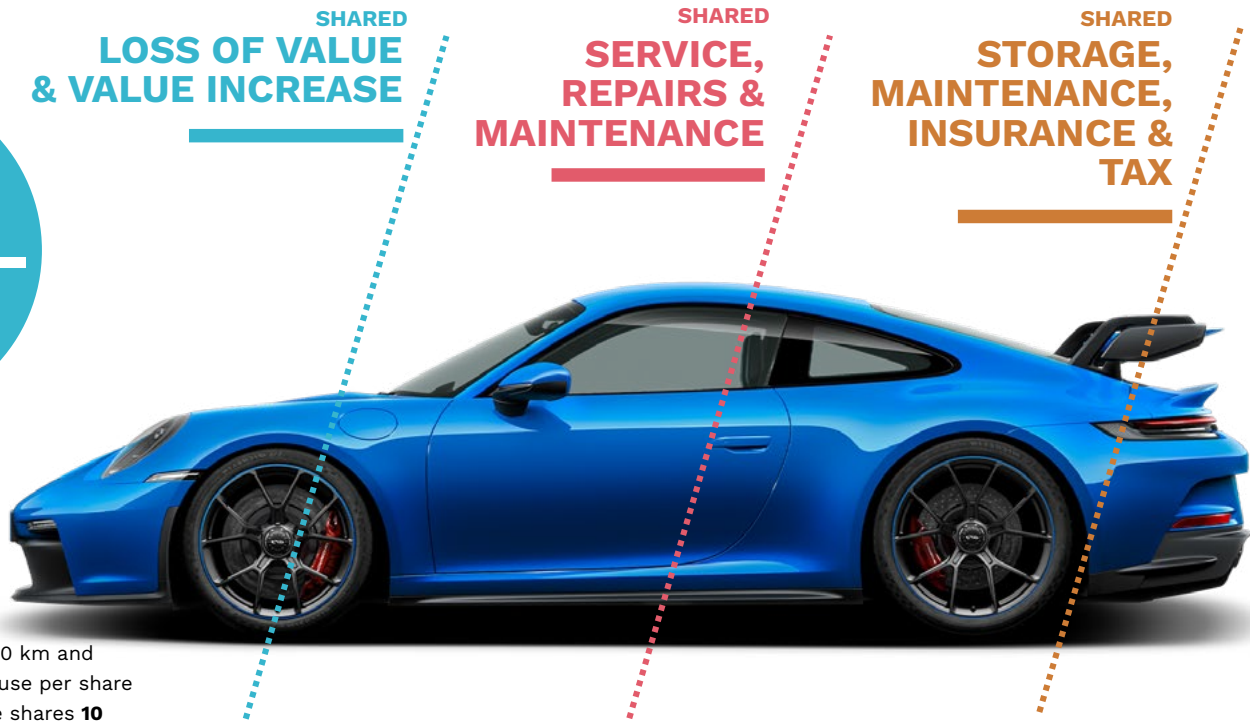

PHASE 1:

In the first step, a group of 3 to 10 Co-Owners for the selected Car from our available offers and stock vehicles comes together. Companies can also purchase shares. Supercar Sharing offers exclusive vehicles to registered users and club members over minimum 28. You can browse, analyze costs/savings, and send us a co-owner request.



PHASE 2:
Registration & Usage

within 7-14 days

In the second step, once all 10 co-owner slots are filled, you'll receive a power of attorney for Europe-wide use. We provide comprehensive insurance, vehicle registration, tax and operational car management, and list you in the vehicle owners register, granting access to the booking app.



PHASE 3:
Resale Phase
Time Period
1 - 12 month

Phase 3 involves advertising the car for sale on the public market after reaching maximum mileage, with options to sell back to a garage, payout the involved Co-Owners, or reinvest in new vehicle.

USAGE & PICKUP

When multiple individuals share a vehicle, its usage is regulated through our App and long-term managed parking spaces and secure garages, in exclusive Car Storages, located throughout Switzerland, Germany, Monaco, and other franchise areas. The vehicle is stored there for shared use and is meticulously prepared for each collection. Handovers are facilitated by one of our employees or a Supercar-Storage service partner. With our comprehensive service, you can rest assured knowing that everything is taken care of, leaving you free from any worries.

To use the vehicle, our co-owners reserve it in advance through the digital booking app. Usage entitlement is calculated based on each co-owner's share of the vehicle. Here's an example, calculated on a 1-year basis:

Days of use per share: 30 days
Use kilometres per share: 2000 km
You acquire: **2 shares (20%)** in the
